Subject:- Authorization for skill development course under up skill initiatives in collaboration with Small Industries Development Bank of India (SIDBI) Govt of India.

The centre for Capacity Building and skill development has completed basic skill course of Cutting & Tailoring from April 2023 to July 2023 under RUSA 2.0 at skill development centre Bazipora, District Bandipora and now they require further training course for 6 months under up skill initiatives so that they shall have the capability to become self reliant and set up their units as start ups in the local area. The identified group of beneficiaries are females who belonging to the BPL, category. it is pertinent to mention that the Hon'ble Vice Chancellor has already launched the Skill Development Centre on 9 November 2023 through e-mode.

In this connection the Small Industries Development Bank of India (SIDBI) has collaborated with our Centre and the proposal submitted to SIDBI has been approved with the financial assistance of Rs. 7, 68,000 which shall be credited in the main account of the CCB & SD operated by the Coordinator for the execution of the programme. The project includes:-

- Six months up skilling training course on cutting tailoring for 25 females.
